The Royal Commission on Institutional Child Abuse has delivered its first findings in NSW where it investigated an ex Scout Leader who was managing an Aboriginal hostel. NSW Community Services and Police were found wanting in the report but so were the Scout processes in the 1990's. It was noted that Scouts have strengthened their processes since then. Scouts had made a report to the police in the 90's but only a vigilant co-worker in

2012 brought the abuse to an end. This is a timely reminder that Child Abuse is everyone's problem and we all need to be vigilant at all times. It is very important that everyone follows the code of conduct and we must all report any incidents to our GL/DC/BHQ. In this Newsletter there is a very informative letter to all members of Scouting from the Chief Commissioner of Australia which will help to keep you all up to date on this issue.

Everyone will be wondering how Geoff Reynolds is recovering from his car accident. The good news is that he is back in Hobart and making good progress. Geoff has been very surprised and pleased with the support he has received from his many friends. He will be shortly moving to St John's Hospital for six weeks rehab., so I am sure that he will be happy to have visitors.

Many of you will be pleased to know that past Chief Commissioner, Lyn Harvey, is back in Tasmania after her four years doing volunteer work in Cambodia. Adventurer Cord / Explorer level Cord Walks:

It has been great to see the increasing number of Scouts progressing through the Award Scheme to earn their Australian Scout Medallion.

Scouts and Leaders are to be congratulated for the effort being put in to achieve this, as both need to be "on the ball" to complete all the requirements.

What has been evident is that there is still some confusion regarding the process of organising the Green Cord walk. There is a Campcraft Journey Policy booklet that clearly gives the options and requirements for all Level Hikes and some pre approved walks. As long as all these requirements are met, you don't need specific permission to journey in that area or for a Pioneer level Hike.

The bit that most Scouts & Leaders are missing is the requirement when preparing the Adventurer/Explorer level Journey Plan, is that the District Scout Leader or qualified Assessor need to approve the Plan at least 3 weeks before the hike. This is to ensure that the DSL is aware of what is happening and that the Scouts are sufficiently organised and capable to undertake the Journey.

Letter from Australian Chief Commissioner

Dear Members of Scouts Australia

I am taking this opportunity to speak with all members of the Scouting Community about the incredibly important matter of child safety and welfare.

Just a few days ago the Royal Commission into Institutional Responses to Child Sexual Abuse submitted its first case study report – looking into systems and circumstances that were in place when Steven Larkins, who was a Scout leader during the 1990s, abused children. Even after Scouts had lodged a report with police, Larkins went on to work as the CEO of the Hunter Aboriginal Children's Service and in 2012 he was found guilty of a number of charges in court.

In review of the Larkins case and, in particular, the child protection system that Scouting had in place during the 1990's, the Royal Commission's Report found that we did not have an adequate system in place. Scouts agrees with the Report's findings in this regard.

As noted in the Report, Scouts changed its procedures and by 2000 the Scouts' Behaviour Management Procedure had altered to require the immediate suspension of an adult member who was the subject of serious allegations, without investigating the matter beforehand.

Today, a specific step-by-step process is used to respond to child abuse allegations. In cases of criminal abuse it includes a complete suspension of the accused adult member and immediate reporting to police and/or other relevant external child protection authorities. Scouts encourages an environment which fosters the immediate reporting of any abuse, and recognises that any delay in reporting can have an impact on everyone involved, especially the victims.

Scouts has zero tolerance for any form of child abuse. It does not conduct any type of investigation for allegations of criminal child abuse and hands any concerns directly to the police for a full, professional investigation.

As recognised by the Royal Commission, Scouts is a very broad, grass-roots and volunteer- run organisation thriving in local communities. But this is no excuse not to adopt the best possible child protection practices uniformly across the country.

Scouts' child protection procedures are now nationally coordinated. All adult members comply with relevant statutory requirements in regard to working with children. Examples include working with children checks, police checks, as well as rigorous vetting and reference check processes.

Different laws do apply in different states, and Scouts looks to the Royal Commission to recommend a single national system so that all Scouts checks, records, recruitment and training programs can focus on building a single, centralised and uniform national system that all community groups can use effectively.

These days, Scouts does not wait for absolute proof of wrong doing. If an issue involving criminal child abuse is raised, we immediately report to the police and suspend the person involved from all Scouting activity.

Scouts would rather err on the side of caution until police have cleared people named in a report. We work closely with the police during this process to ensure the investigation has access to all the information available.

The safety and protection of young people is Scouts' highest priority. We have zero tolerance for any form of abuse.

The Royal Commission's Report looked at the other organisations that Steven Larkins had manipulated, for instance by falsifying working with children checks.

Scouts was extremely disappointed that Larkins only received a light sentence after being found guilty of two counts of aggravated sexual assault of children. In fact, he has not served a day in prison for these crimes. Yet for the charges of possession of child pornography, falsifying working with children's checks and statutory declaration documents he was given a 19 month custodial sentence.

Scouts believes that Larkins should have served substantial custodial time for aggravated sexual assault of children and we raised the issue with the NSW Government in 2012 and are participating in a review of NSW sentencing at the moment.

From the very beginning, Scouts has been a vocal supporter of the role of the Royal Commission. We hope that by studying these complex cases, the Royal Commission can build a better national system which coordinates the many organisations working with children to ensure their protection, safety and wellbeing.

From youth groups to police, from government departments to local health services, and of course always in every aspect of Scouting, we must all operate under a coordinated and rigorous child protection system.

Scouts will keep you updated on any outcomes from the Royal Commission which involves Scouting, or which will impact our tough and unbending child protection processes.
